Note 2: Following the issue of this further amount of the Gilt, 23/4% Treasury Gilt 2024 may be stripped and holdings of the Gilt reconstituted: the provisions relating to strips contained in the Information Memorandum, will therefore apply except that the minimum stripping unit will be £1,000,000 nominal until the payment of

the non-standard first coupon on 7 September 2014. The SEDOL and ISIN codes for the new principal strip are B-LSN-W78 and GB00BLSNW788 respectively.

Note 3: Holders may elect to have United Kingdom income tax deducted from interest payments, should they so wish, on application to the Registrar, Computershare Investor Services PLC.

Note 4: Subject to the provisions of the Information Memorandum, this auction will be eligible for the Post Auction Option Facility of an additional amount of the Gilt equivalent to 10% of the nominal amount of the Gilt allocated at the auction. Details of the Post Auction Option Facility procedures are set out in the Information Memorandum.
