### RESULT OF THE SALE BY AUCTION OF £3000 MILLION OF 0¾% TREASURY GILT 2023

The United Kingdom Debt Management Office ("DMO") announces that the auction of £3,000 million of 0¾% Treasury Gilt 2023 (ISIN Code: GB00BF0HZ991) has been allocated as follows:

(Note: all prices in this notice are quoted in pounds and pence)

- All bids which have been accepted at the lowest accepted price have been allotted 8.8187% of the amount bid for.

Competitive bids made at prices above the lowest accepted price have been allotted in full. Competitive bids made at prices below the lowest accepted price have been rejected.
