



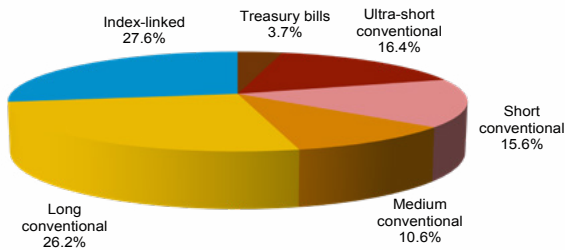

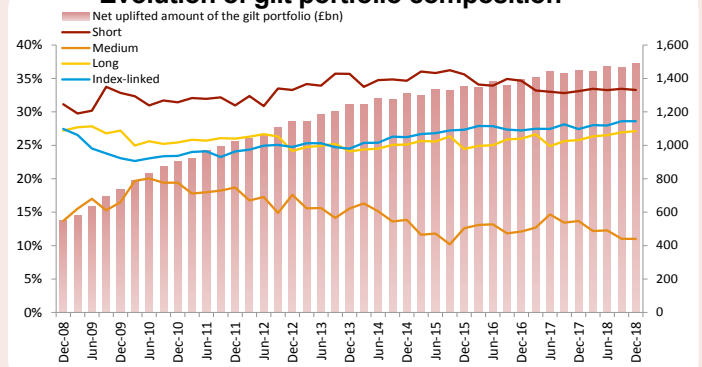

### Composition of gilt and Treasury bill portfolio



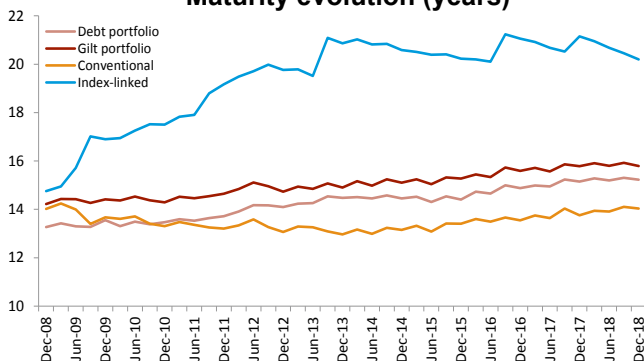

### Evolution of gilt portfolio composition



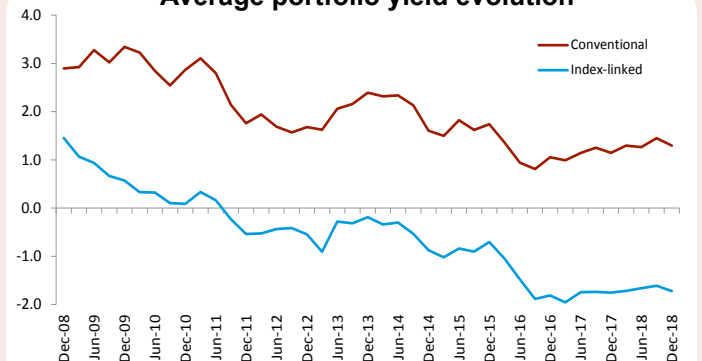

### Average portfolio yield evolution

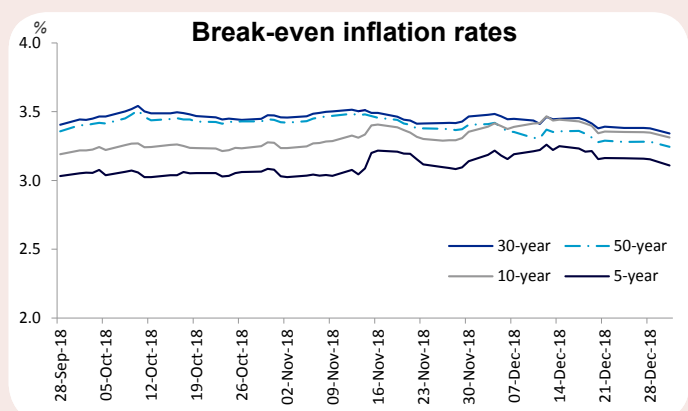
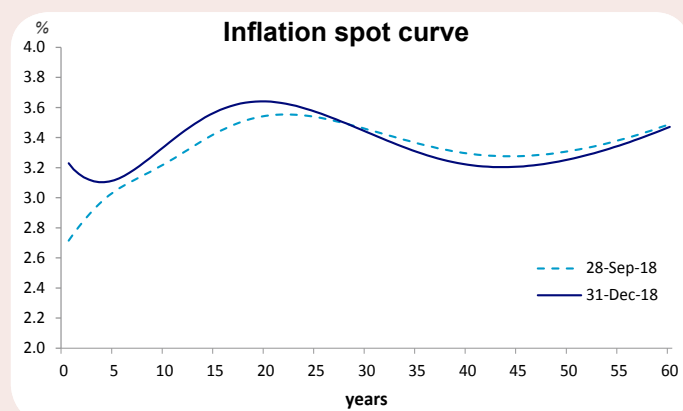
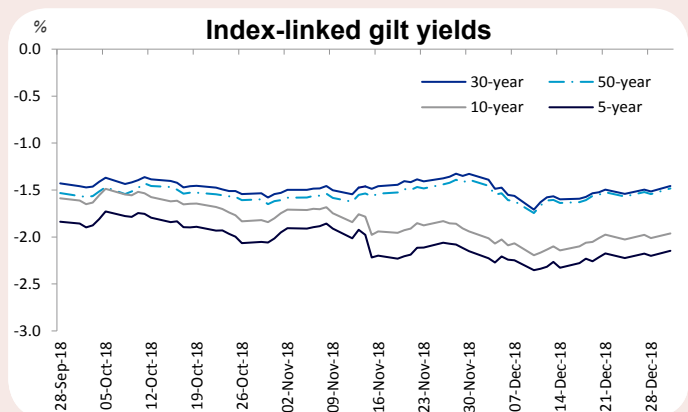
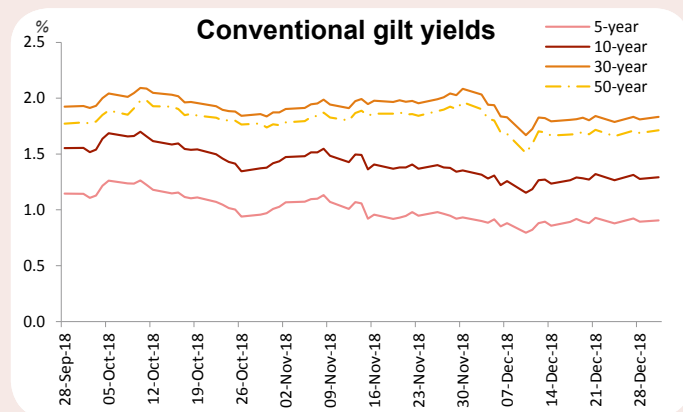
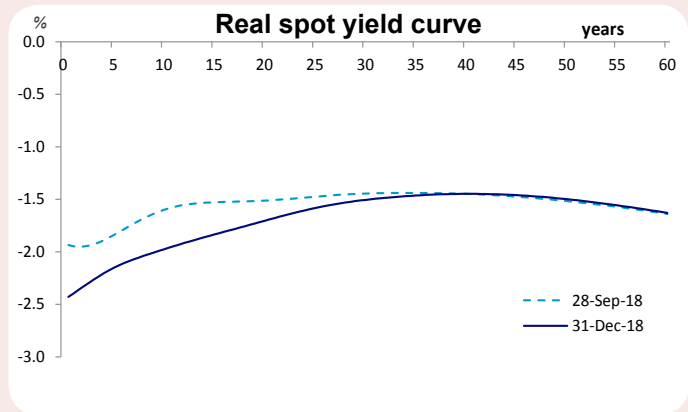
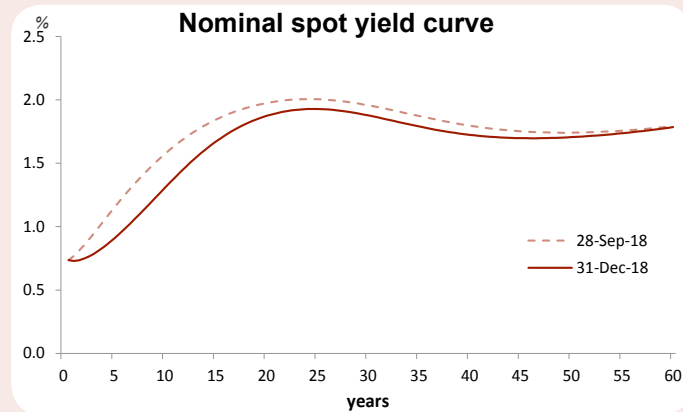

# Turnover

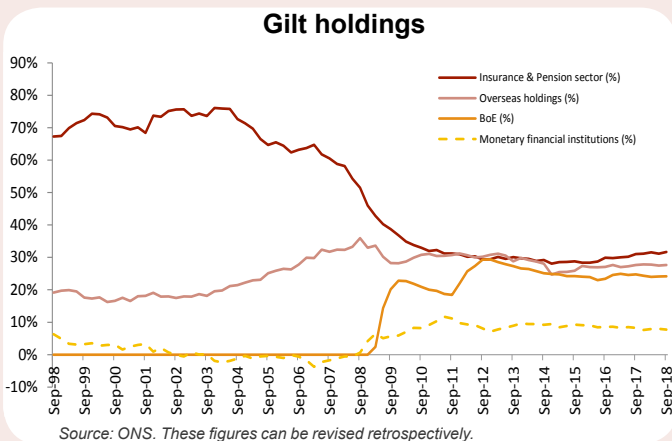

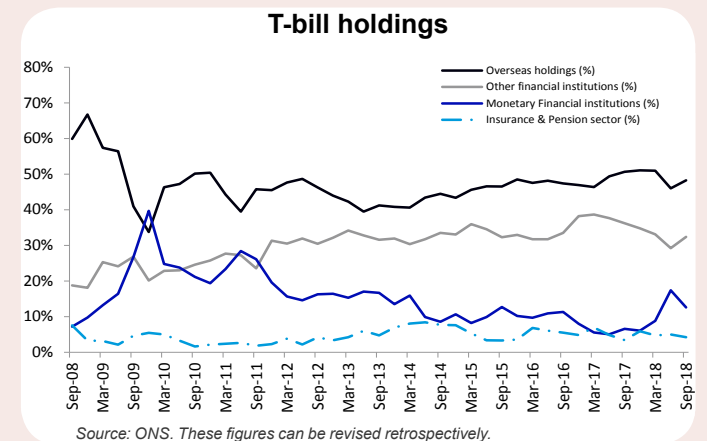

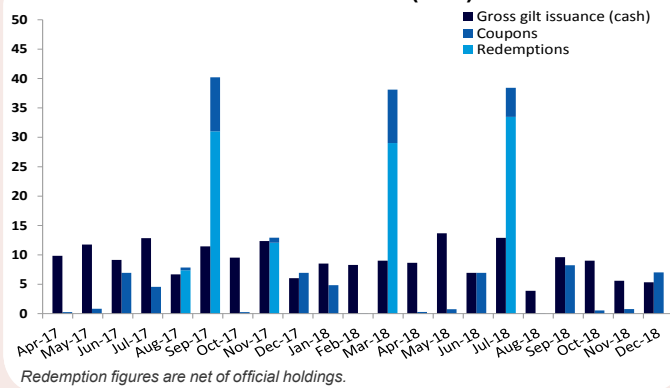

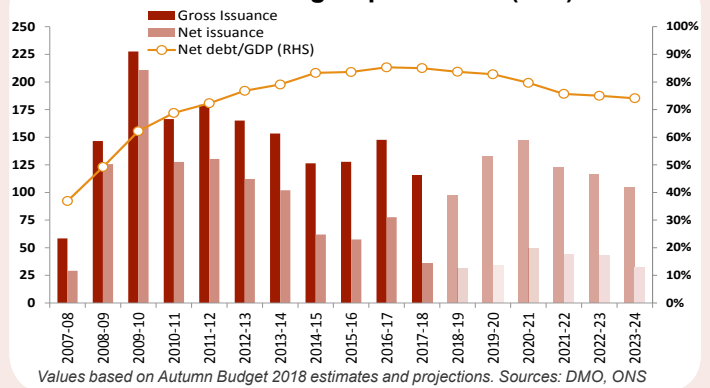

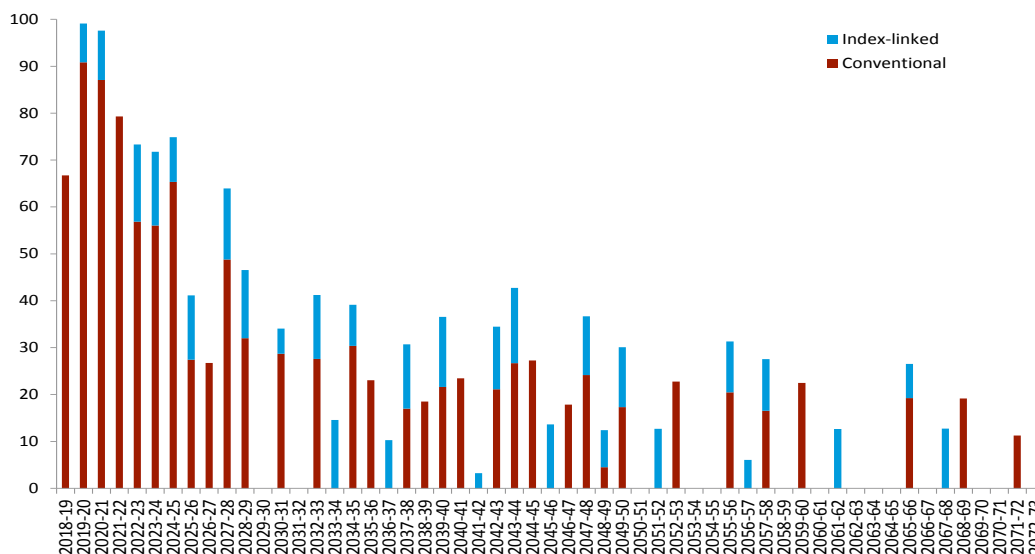
**Gilt market flows (£bn)**

They are calculated in a way consistent with the formulation of the Government's financing requirement; i.e. that part of the accrued inflation uplift on any redeeming gilts that represents the return to investors is included in the CGNCR in that redemption year, and the remainder is included in the redemption total for the year in which the relevant gilt redeems.

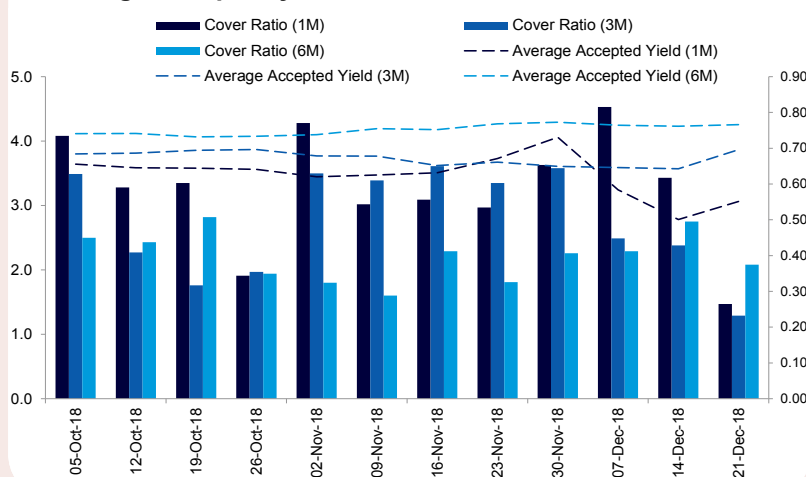
