RESULT OF THE SALE BY TENDER OF UP TO £750 MILLION OF 4¾% TREASURY GILT 2030

The United Kingdom Debt Management Office ("DMO") announces that the tender of up to £750 million of 4¾% Treasury Gilt 2030 (ISIN Code: GB00B24FF097) has been allocated as follows:

(Note: all prices in this notice are quoted in pounds and pence)

- All bids which have been accepted at the lowest accepted price have been allotted 67.1428% of the amount bid for.

Competitive bids made at prices above the lowest accepted price have been allotted in full. Competitive bids made at prices below the lowest accepted price have been rejected.
