RESULT OF THE SALE BY AUCTION OF £3,500 MILLION OF 4½% TREASURY GILT 2013

The United Kingdom Debt Management Office ("DMO") announces that the auction of £3,500 million of 4½% Treasury Gilt 2013 has been allotted in full.

(Note: all prices in this notice are quoted in pounds and pence)

1. All bids which have been accepted at the lowest accepted price have been allotted approximately 35.5% of the amount bid for.

Competitive bids made at prices above the lowest accepted price have been allotted in full.
Competitive bids made at prices below the lowest accepted price have been rejected.
