RESULT OF THE SALE BY AUCTION OF £4000 MILLION OF 41/2% TREASURY GILT 2035

The United Kingdom Debt Management Office ("DMO") announces that the auction of £4,000 million of 4½% Treasury Gilt 2035 (ISIN Code: GB00BT7J0027) has been allocated as follows:

1. All bids which have been accepted at the lowest accepted price have been allotted 39.6825% of the amount bid for.
