In addition, Her Majesty's Treasury has created on 30th December 1992, and has issued to the National Debt Commissioners for public funds under their management, an additional amount of £100 million of the same Stock.

The amounts issued on 30th December 1992 represent further tranches of the Stock, ranking in all respects pari passu with that Stock and subject to the terms and conditions applicable to that Stock, and subject also to the provision contained in the final paragraph of this notice; the current provisions for Capital Gains Tax are described below.

Application has been made to the Council of The International Stock Exchange for the further tranches of the Stock to be admitted to the Official List.

The Stock is repayable at par on 30th March 1998, and interest is payable half-yearly on 30th March and 30th September. The further tranches of the Stock have been issued partly paid; a final call of £74.50 per cent is payable on 28th January 1993. The further tranches of the Stock will rank for the interest payment of £1.6958 per cent due on 30th March 1993. Official dealings in the Stock on The International Stock Exchange are expected to commence on Thursday, 31st December 1992.
