RESULT OF THE SALE BY AUCTION OF £4000 MILLION OF 3¾% TREASURY GILT 2027

The United Kingdom Debt Management Office ("DMO") announces that the auction of £4,000 million of 3¾% Treasury Gilt 2027 (ISIN Code: GB00BPSNB460) has been allocated as follows:

(Note: all prices in this notice are quoted in pounds and pence)

- All bids which have been accepted at the lowest accepted price have been allotted 47.1428% of the amount bid for.

Competitive bids made at prices above the lowest accepted price have been allotted in full. Competitive bids made at prices below the lowest accepted price have been rejected.
