RESULT OF THE SALE BY AUCTION OF £3,000 MILLION OF 4% TREASURY GILT 2022

The United Kingdom Debt Management Office ("DMO") announces that the auction of £3,000 million of 4% Treasury Gilt 2022 has been allocated as follows:

(Note: all prices in this notice are quoted in pounds and pence)

1. All bids which have been accepted at the lowest accepted price have been allotted approximately 65.0% of the amount bid for.

Competitive bids made at prices above the lowest accepted price have been allotted in full.
Competitive bids made at prices below the lowest accepted price have been rejected.

to-member deliveries on the relevant settlement date if they so requested.

*Tail is calculated as the yield at the lowest accepted price less the yield at the average accepted price (using unrounded yields). This figure is then multiplied by 100 to convert it into basis points.
