RESULT OF THE SALE BY AUCTION OF £2500 MILLION OF 01/4% TREASURY GILT 2031

The United Kingdom Debt Management Office ("DMO") announces that the auction of £2,500 million of 0¼% Treasury Gilt 2031 (ISIN Code: GB00BMGR2809) has been allocated as follows:

1. All bids which have been accepted at the lowest accepted price have been allotted 73.3333% of the amount bid for.

Competitive bids made at prices above the lowest accepted price have been allotted in full. Competitive bids made at prices below the lowest accepted price have been rejected.
